

Dear PTA Leaders,

I am pleased to report that 100 national and state organizations—including 52 PTA state congresses—have signed on to a letter to support funding Statewide Family Engagement Centers (SFECs) at \$10 million in fiscal year 2018. The attached letter is for your files and will be listed on our webpage later today under letters to policymakers. The letter was sent this afternoon to all Senators and their staff on the Labor, Health and Human Services, Education and Related Agencies (L-HHS-ED) appropriations subcommittee. The attached Senate letter surpasses the 88 national and state organizations that signed on to a similar House letter earlier this year—which included the same 52 state PTAs.

Additionally, National PTA's Government Affairs Department announced last week to State PTA Presidents and Federal Legislative Chairs that the Senate Dear Colleague letter in support of funding SFECs in fiscal year 2018 was circulated in the Senate with Senators Chris Coons (D-DE) and Thom Tillis (R-NC) leading the letters for their respective political parties. As of 10 a.m. this morning, we received notice that there are 10 Senators (listed below) that have signed on to the Dear Colleague letter. Dear Chairman Blunt and Ranking Member Murray:

The 100 undersigned organizations write in support of robust funding for the Statewide Family Engagement Centers grant program and respectfully request no less than its authorized level of \$10 million—in the FY 2018 Labor, Health and Human Services, Education and Related Agencies (L-HHS-ED) appropriations bill.

The Statewide Family Engagement Centers (SFECs) grant program is one of the few non-categorical programs from No Child Left Behind (NCLB) that was maintained in the Every Student Succeeds Act (ESSA). Both the House of Representatives and the Senate recognized the importance of parent and family engagement in education by including the SFECs program as a standalone program in their respective reauthorization bills. Known as the Parental Information and Resource Centers (PIRCs) under NCLB, the improved SFECs program will build capacity for states and school districts to systematically embed family engagement policies and practices in their education plans. The SFEC program will provide much needed professional development for educators and school leaders to strengthen school-family partnerships and parent-teacher relationships. Additionally, SFECs will provide direct services to families to give them the tools to effectively work with their child's school to improve their child's academic outcomes and overall well-being.

With ESSA implementation underway, states, school districts, school leaders and parents need the SFEC program to effectively engage parents as stakeholders and successfully implement the law as Congress intended. Research shows that family engagement advances the academic and developmental progress of our nation's children and drives increases in student achievement. Our organizations believe that an investment in SFECs is critical to ensuring that families are meaningfully supported and engaged in their child's education so they can support our nation's students in becoming fully prepared for higher education, workforce and career opportunities in the 21st century.

A Dear Colleague letter to fund Statewide Family Engagement Centers is being circulated and we hope that you will show your support for the program by signing on. Thank you for your consideration of our request and we look forward to working with you to ensure this important program receives funding in FY 2018.
