## **Adopted Amendments to the Tennessee PTA Bylaws**

### **Motion 1:**

If adopted, Article X, Section 7.a would read:

Regular meetings of the Board of Directors shall be held in the summer, fall, and before each annual meeting. Regular meetings may be conducted by use of any means of communication by which all directors participating may simultaneously hear each other during the meeting. A director participating in a meeting by this means is deemed to be present at the meeting.

### **Explanation of the change**

The Tennessee PTA Board of Directors regular meetings may now have virtual attendance that can be counted towards quorum. The adopted changes meet State of Tennessee requirements for nonprofits.

### **Motion 2:**

If adopted:

Article XI Section 2.a would read: The Executive Committee shall:

Meet in regular session immediately before each meeting of the Board of Directors. Executive Committee meetings shall be conducted by use of any means of communication by which all participating may simultaneously hear each other during the meeting. All participating in a meeting by this means are deemed to be present in person at the meeting.

### Article XVII Section 1 would read:

There shall be an annual meeting of the Tennessee PTA, preferably in April (except under conditions set forth in Section 6.) The time and place of the annual meeting shall be determined by the Board of Directors. Official call of such meetings shall be sent to the Board of Directors and to council and local unit Presidents at least sixty (60) days prior to the meeting. Annual meetings shall be conducted by use of any means of communication by which all participating may simultaneously hear each other during the meeting. All participating in a meeting by this means are deemed to be present in person at the meeting.

### Article XVII Section 7 would read:

Special meetings of the membership may be called by the President or by written request of at least fifty (50) members. Notice and purpose of the special meeting shall be given to all members at least fifteen (15) days prior to the meeting. Special meetings shall be conducted by use of any means of

communication by which all participating may simultaneously hear each other during the meeting. All participating in a meeting by this means are deemed to be present in person at the meeting.

### **Explanation of the change**

The meetings of the TNPTA Executive Committee, the TNPTA Annual Meeting, and a special meeting of the TNPTA membership may now have virtual attendance that can be counted towards quorum. The adopted changes meet the State of Tennessee requirements for nonprofits.

### **Motion 3:**

If adopted Article VII, Section 2.a would read: Only a member of a Tennessee local unit PTA in good standing shall be eligible to hold office in Tennessee PTA. The nominee(s) shall have served at least one year as committee chair or officer in a local, council or state PTA in any of the National PTA constituent associations.

### **Explanation of the change - Officer Eligibility for Nomination**

A nominee for an elected office in Tennessee PTA, except for the position of president-elect, no longer requires service of at least a term on the Tennessee PTA board of directors to be eligible, but now, officer eligibility is expanded to be anyone who has served at least one year as committee chair or officer in a local PTA unit in good standing, or a council unit in good standing, or a state PTA in any of the National PTA constituent associations.

### **Amendment Not Adopted to the Tennessee PTA Bylaws**

Motion 4 was not adopted by the annual meeting delegates.

### **Amendments Not Yet Considered**

Motions 5 through 8 were not considered by the delegates at the 2022 annual meeting, but they might be brought to the 2023 Annual Meeting.

### Tennessee PTA Board of Directors' Annual Report

What has your all-volunteer Tennessee PTA Board of Directors done during the 2021-2022 year? Tennessee PTA Board of Directors has represented you well. We have spent numerous hours speaking about educational and health and safety issues affecting students, parents, communities, school staff, school districts: rural, urban, & suburban. Tennessee PTA has also offered virtual and in-person leadership training and helping new and seasoned PTA leaders at all levels.

The Tennessee PTA Board of Directors meets quarterly as a whole group. The 12 members of the Board collectively logged in more than 2000 hours just during the meeting portions of these weekends. Each member sits on four or more state PTA committees and some also serve on additional statewide educational boards and committees. They work in between meetings doing such things as: working on legislative issues, tracking membership, starting new PTA's, approving bylaws, running the Reflections program, answering units questions, visiting local units & councils, planning events and conferences, contacting units with reminders, attending training workshops, and writing newsletter articles. Tennessee PTA has also be working on developing partnerships through two National PTA grants and two grants from outside National PTA to spread the message out across the state on the importance of parent engagement and educational data.

Below is a summary of the Tennessee PTA Board of Directors' accomplishments.

☐ Hosted five in-person leadership training sessions during August and September. Training was held in the East Tennessee, First Tennessee, Southeast, Mid Cumberland, and Memphis Delta regions.
□ Receive a grant from GoGuardian to lead a Mental Health Webinar in September and to partner with families about technology surveys.
□ Sponsored a Mental Health Webinar in September with partners GoGuardian and Centerstone. The webinar was open to all parents and families in Tennessee.
□ Received a grant from the Gates Foundation to gather opinions about educational funding in Tennessee and about crossing the gap from high school to post-secondary.
☐ Traveled many miles in support of our local units, councils and membership.
☐ Received a grant from National PTA to promote mental health awareness
☐ Aligned designated board members with our collaborating agencies
□ Led a workshop in January about what is BEP.
☐ Led a workshop in February about what is the new funding formula.
☐ Partnered with Tennessee Rural Education Association with an education funding meeting in November.
☐ Partnered with the Tennessee Department of Education to sponsor eight public listening sessions.
□ Published our Legislative Priorities
□ Distributed five newsletters
□ Partnered with Urban League of Chattanooga to build a multi-tracked survey to parents, students, recent graduates, and community members about education funding.
□ Participated in Tennessee Department of Education committees and parent council.
☐ Held a statewide focus group with National PTA about the National Standards for Family-School Partnership in January.
□ Participated in monthly meetings with our advocacy alliance partners and received a grant from one of our alliance partners to promote advocacy on educational issues in Tennessee
☐ Held several Q&A with Tennessee PTA meetings throughout the year led by our Family & Community Engagement Committee.
□ Graduated four Leadership Academy Participants
□ Attended National PTA Convention
☐ Attended quarterly advocacy and membership and financial training
☐ Attended monthly all-state president and all-state president elect meetings
□ Partnered with Sycamore Institute to provide important data for workshops
☐ Met with several organizations across the state
☐ Recommended House Bills and Senate Bills for committee members to watch that will affect our students and
parents
□ Sponsored an advocacy petition in September
